August 13, 2020

Meeting opened at 5:30 with Chairman Greg Nordwig, Supervisor Michael Trinko, Supervisor Carolyn Jolitz, Treasurer Sherry Voelz, Clerk Raymond Rigsby, and 1 in attendance.

Chairman Nordwig led saying of Pledge of Allegiance.

Minutes from July were approved as read.

Roads.

Chairman Nordwig reported status of School House Bridge. State inspected resulting in closure and barricading. Expectation is funding possible next year from the State's Emergency Bridge Aid with 80% State and Federal Aid and 20% from the Town.

Roosevelt Road TRIP funds (\$49,683.68) released. Supervisor Jolitz will meet with Nordin & Associates to do bid for work in the Spring. Intent is to start at culvert and do one mile with option to do less as was done with Zimdars Road.

Supervisor Jolitz reported on crack filling, culvert and pothole work completed with brushing scheduled for the Fall.

Supervisor Trinko motioned and Supervisor Jolitz seconded to submit to Shawano County a Request to Allow ATV/UTV Usage on County Road G from the Intersection of County Road G and Campground Road to the Seneca Town Line connecting it with Town of Herman's County Road G access. Motion Carried.

Supervisor Trinko motioned and Supervisor Jolitz seconded to submit to Shawano County a Request to Allow ATV/UTV Usage on County Road D from Intersection of County Road D and School House Road South to the Intersection of County Road D and Fish Hatchery Road given the recent closure of the School House Bridge. Motion Carried.

Action postponed on Frontier Communications Permit to place Fiber Optic along Town Right of Ways on Roosevelt Road and Ball Park Road until after Supervisor Trinko does on-site with contractor.

Supervisor Trinko motioned and Supervisor Jolitz seconded to increase Liquor Licensing Fees for the 1-Year Period Beginning July 1<sup>st</sup> 2021 to \$50.00 from \$25.00 for Class B Beer, \$125.00 from \$75.00 for Class B Liquor Combo License and to \$10.00 from \$3.00 for Servers License. Motion Carried.

Chairman Nordwig gave Ambulance meeting update.

Supervisor Trinko gave a Fire Meeting update with changes to fees for Towns still being considered and need for purchase of new fireman turn out suits.

Supervisor Jolitz gave a Tilleda Pond District annual meeting update.

Supervisor Trinko made a motion and Supervisor Jolitz seconded to approve bills. Motion carried.

Public Input.

County Supervisor Erdman gave County update to include Maple Hill and Utilities and on-going budget process.

Chairman Nordwig adjourned the meeting at 6:18 PM.
