Meeting opened at 5:30 with Chairman Greg Nordwig, Supervisor Michael Trinko, Supervisor Carolyn Jolitz, Treasurer Sherry Voelz, Clerk Raymond Rigsby, and 3 in attendance.

Chairman Nordwig led saying of Pledge of Allegiance.

Minutes from April were approved as read.

Roads.

Supervisor Jolitz reported Town road grading conducted with graveling needs identified during Spring Road Inspections to commence next week. Two Barriers placed on Roosevelt Road have missing. Clerk will order four. Pothole patching conducted by Meverdin and brushing to start end of May. Supervisor Trinko reported he would remove silt fencing on Zimdars Road. Supervisor Jolitz will check crushed rock driveway on property off Buckowski Lane referenced as "Old Reedy Property".

Supervisor Trinko motioned and Supervisor Jolitz seconded to have Shawano County Highway Department do patching work on four locations on Seneca and Schoolhouse Roads for \$7,500. Motion Carried.

Supervisor Trinko motioned and Supervisor Jolitz seconded to approve CWEC Utility Placement Permit for N5770 Weasel Dam Road, Roger Jolitz owner. Motion Carried.

Board discussed Wisconsin Tavern League Proposal to reduce Municipal Liquor License Fees for 2020-2021 in response to COVID-19 effects on small business. Tabled - No action. Board directed fee schedule be placed on future agenda for discussion.

Board discussed Mass Mailing in order to get word out on completing Census 2020. Tabled till June 2020 meeting.

Board discussed conducting 2020 Revaluation of Property Class 5 (Undeveloped), 5M (Agricultural Forest), 6 (Forest), and 7 (Other) as required by State Law due to low 2019 Municipal Assessment Value Ratio (74.57%) resulting in Major Class Non-Compliance Status. Tabled till June 2020 meeting.

Supervisor Trinko motioned and Supervisor Jolitz seconded to sign Multimodal Local Supplement (MLS) Award State/Municipal Agreement (SMA) electronic document signing. Motion Carried. Chairman Nordwig will send it to State.

Supervisor Jolitz motioned and Supervisor Trinko seconded to approve Wisconsin Towns Association Membership. Motion Carried.

Supervisor Jolitz motioned and Supervisor Trinko seconded to approve Shawano County Highway Department Conducting Annual Bridge Inspections. Motion Carried.

No Meeting updates provided.

Supervisor Jolitz gave update from County (Andy Popp) on Rosenow Property issue with second citation issued.

Supervisor Trinko made a motion and Supervisor Jolitz seconded to approve bills. Motion carried.

Public Input.

Harvey Stefl reminded the Board about need to do road crack filling and asked whether the Jolitz Weasel Dam culvert was going to be placed into compliance with Town Ordinance. Board reported Property Owner notified and correction would be made.

Chairman Nordwig adjourned the meeting at 6:25 PM.
