Meeting opened at 5:30 with Supervisor Michael Trinko, Supervisor Harvey Stefl, Clerk Raymond Rigsby, Treasurer Sherry Voelz, and 2 in attendance.

Supervisor Trinko led the Pledge of Allegiance.

Minutes from September were approved as amended

Roads.

Supervisor Trinko gave a roads update from the Fall Roads inspection to include pothole filling started by Supervisor Trinko was finished by Marosovec on School House, North Branch, Pony Creek, Old 29, Nursery Lane, and Part of Roosevelt. Grading was also completed with recommendation to do it three times next year instead of two. Brushing was discussed with spraying completed for the year. Culverts will need to be replaced on School House, River, and Hatchery with crack sealing on Zimdars, Roosevelt and Campground. Gravel is needed on the end of Hatchery and Pony Creek.

Clerk Rigsby provided School House Road LRIP update. Nrodin & Associates provided a West of Bridge (\$364,300.00) and East of Bridge (\$365,740.00) estimate that will need to be adjusted to ensure 2 1/2 " to 3" HMA instead of 2" at an additional cost of \$80,000. Plan is to submit as an LRIP Project in November.

Supervisor Stefl gave Leopold Road update to include damage project is ongoing with shoulder work starting 12 September.

Supervisor Trinko made a motion and Supervisor Stefl to Approve Certified Survey Map (Dean Watters) Part of the SW ¼ NE ¼, Section 32, T27N-R13E, Town of Seneca, Shawano County, Wisconsin. Motion Passed.

Supervisor Trinko made a motion and Supervisor Stefl to continue increased levy limit for 2025 to be collected in 2026 to cover outstanding road construction loans. Motion Passed.

Supervisor Trinko made a motion and Supervisor Stefl seconded to approve bills. Motion carried.

Facility update. Supervisor Trinko reported Robbie Maas has not gotten back to him about the hall's north wall powerwashing. Supervisor Trinko will look at hole in wall reported by Supervisor Stefl.

Public Input.

Glenda Butterfield-Boldig, Bowler School District Superintendent gave a Bowler School District update.

County Supervisor Trinko gave an update on County budget process.

Supervisor Trinko adjourned the meeting at 5:55 PM.
